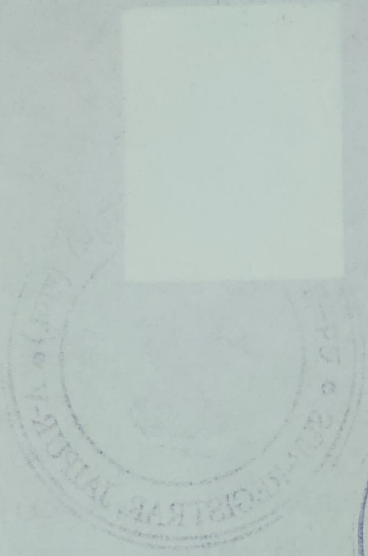
NOW THIS TRUST DEED WITNESSES AS FOLLOWS:

1. **NAME:** The name of the trust shall be "AASHAYEIN FOUNDATION"
2. **REGISTERED OFFICE:** That the registered officer of the Trust shall be situated at **Makan No. 3, Ward No. 1, Ambikashwar Mandir Ke Piche Sagar Road, Amer – Jaipur, Rajasthan – 302028, India**, or at such other place or places as the Trustees may

decide from time to time. Branch/ administrative office can be opened in any part of the country for the smooth functioning of the trust.

3. **NAME OF BOARD:** All the Trustees of this Trust shall collectively be called as "Board of Trustees"

4. **INITIAL CONTRIBUTION:** The Board of Trustees shall hold a sum of Rupees 10,000.00 (Rs Ten Thousand Only), this day paid to them and all monies, funds, other movable or immovable properties and income thereof which may hereinafter be received by the Board of Trustees from time to time as Gifts, donations, Grants, Subscriptions or otherwise for the purposes of the trust and the Trust fund shall vest in the Trustees jointly.

5. **MAIN OBEJCTS:** That the objective of the Trust shall be wholly for the public and charitable purposes and incomes shall be applied for the same and accumulated in India wholly for public and charitable purposes without prejudice to generally of provisions aforesaid and the following shall be deemed to be the principal & main objectives of **AASHAYEIN FOUNDATION:**

- a. To establish and run Blood donation camps, Blood Bank, research and development centres, blood diagnostic centres, pathology centres, libraries, and publications.
- b. The distribution of a mix of disposable and sustainable cloth sanitary napkins and other menstrual products to women and young girls if and as required.
- c. To foster a sustainable improvement in menstrual hygiene practices amongst young girls and women of the tribal communities.
- d. The conduct of extensive outreach, mobilisation and awareness programs to educate the communities about menstrual hygiene and sanitation.
- e. Mobilizing and employing local women, influencers, and leaders in the project to create sustainable change.
- f. The development and dissemination of Information, Education, and Communication (IEC) materials in the local dialects to enhance understanding and acceptance of menstrual health practices.

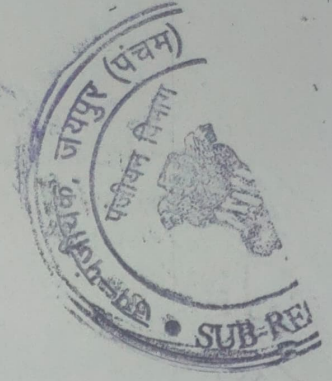
6. **ADDITIONAL OBJECTS:** The Additional objects of the trusts are as below:

- c. To promote gender equality; empowering women; setting up homes and hostels for women and orphans; setting up old age homes; day care centres and such other facilities for senior citizens and economically backward groups.
- d. To ensure environmental sustainability, ecological balance, protection of flora and fauna, animal welfare, agro-forestry, conservation of natural resources and maintaining quality of soil, air and water.

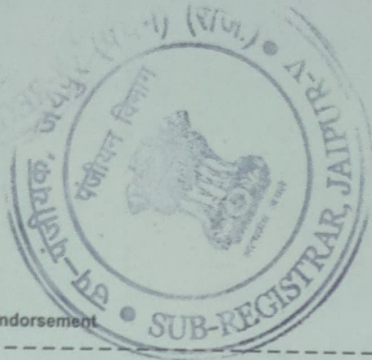
- x. To expend lawfully any money belonging to the Trust for the purpose of the Trust.
- y. To do all activities as defined under schedule VII of the Companies Act, 2013 and any amendment therein, as may be carried out from time to time.
- z. To form and run one or more Trust/s for Charitable Activities.
- y. To establish and run Blood donation camps, Blood Bank, research and development centres, blood diagnostic centres, pathology centres, libraries, and publications.

7. **POWER OF MANAGING TRUSTEE:** The Managing Trustee shall have the following powers:

- a. To manage the properties, assets and funds of the Trust, from time to time, such regulations (not being consistent with this deed) as they may think fit for and necessary for the purposes of such management and control; or in connection with the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- b. To accept donations, contributions, grants, subscription in cash or in kind from any person, company, from, association, organization, government, non-government or semi government agencies, national or foreign funding agencies, family Trust or corporate bodies for furtherance and achievement of the objective of the trust.
- c. To enforce resolution of any nature passed by managing committee
- d. To review of the trust as necessary.
- e. To appoint officers and members of staff for the trust and to prescribe their condition of service.
- f. To open and to provide for operating banking accounts
- g. To rise loans with or without security or to invite donations and financial help.
- h. To receive the salary and honorarium against his/her services or involvement in any of the project or program run by the Trust, which must be decided by the Board of Trustees/Managing Trustee and approved by the Chairperson.
- i. To authorize person (s) to sign or execute documents on behalf of the trust.
- j. To grant receipts for aid and donations received.
- k. To grant special Power of Attorney to represent the Trustees in connection with any legal or other proceedings.
- l. To acquire land or building on the lease or way of purchase.
- m. To compromise, compound or refer to Arbitration all actions, proceeding, and disputes relating to Trust property or properties.
- n. To sell, purchase or give on rent/ lease or on hire any movable & immovable property of the Trust for some certain period or permanently on such terms and conditions as the Trustees may think fit and proper from time to time.
- o. To open any type of bank account (s) weather saving account, current account, fixed or otherwise, in the name of the Trust or institution (s) run by the Trust with any scheduled banks (s) or post office (s) and to operate by the authorized signatory or signatories as Board of Trustees shall think fit and proper to authorized any person

The financial Year for the Trust shall be from 1st April to 31st March and the accounts of Trust or institution (s) or programs/projects (s) run by the Trust shall be audited yearly by the auditors b(s) or chartered accountant or a firm of chartered accountants to be appointed by the Board of Trustees and the fee paid shall be a part of outgoing amounts from the Trust Funds.

- p. To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to carport bodies, persons, firms, institutions, as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.
- q. To gift, lease, and transfer the immovable and moveable properties of the Trust.
- r. To appoint lawyer, pleaders, advocated to file and defend suit or suits filed for and against the Trust and or in name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceeding and delegate power the officers(S) employee(s), staff(s) and Trustees(s) for such proceedings(s) as required from time to time.
- s. To appoint new member or members of Board of Trustees by a resolution and to discharge any of Trustees, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or become of unsound mind or is otherwise unfit to continue as Trustees, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.
- t. To appoint from time to time on such terms and conditions as they may determine a Secretary, Manager, Executive Director(s) and other officer(s) or members(s) of staff for carrying out the activities of the Trust and to remove at any time any such Secretary, Manager, Executive Director, Director(s) and other officer(s) or members(s) of staff.

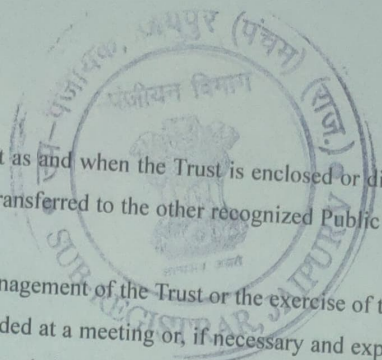
8. OTHER BY LAWS & REGULATIONS OF TRUST: the Trust will have the following additional by lays for the operational activities of the Trust:

- a. After defraying all necessary expenses incurred in the collection or realization of the income from the Trust ten percent (10%) of the balance of the income shall be kept in a reserve fund to be utilized when, in the opinion of the Board of Trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust.
- b. The Trustees shall invest the Trust fund in government securities, saving certificates, fixed deposits, or any other form of investment authorized under provision of INDIAN TRUST ACT, 1882 and RAJASTHAN PUBLIC TRUST ACT, 1959 and INDIAN INCOME TAX ACT, 1961, as they shall deem expedient.





- c. It has further been decided that as and when the Trust is enclosed or dissolved all the funds of the trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.
- d. All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by a majority of the Trustees present and voting in any meeting of Board of Trustees or by the circulation, as the case may be and any action or decision of such majority shall be as valid as if it was done or made by the all Trustees. The Chairman / Chairperson shall have a casting vote.
- e. In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustees or any other cause, new Trustees may be appointed to fill the Vacancy.
- f. All matters not provided for in this Trust deed but necessary for the administration of the Trust of for giving effect to the objectives of the trust may by resolution(s) made by the Board of Trustees carried by a special majority of two third of total number of the Trustees.

9. **AREA OF OPERATION:** "AASHAYEIN FOUNDATION" will be liable to work and operate in all states and Union territories of INDIA.



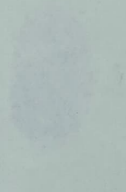
